

**36th Annual Dirty Dozen Bicycle Ride  
November 24, 2018  
Release and Waiver of Liability Agreement**

I acknowledge that I have voluntarily applied to participate in the 36th Annual Dirty Dozen Bicycle Ride (the Ride). **I acknowledge that the Ride is held on open roads with vehicle traffic and I accept responsibility for my own safety and actions during the Ride. I acknowledge that the route taken by the Ride is very physically challenging and I represent that my health, fitness and the condition of my equipment are such that my participation in the Ride will not endanger myself or others.**

I am aware that participation in the Ride is hazardous and that I could be seriously injured or even killed. I am voluntarily participating in the Ride with knowledge of the danger involved, and I agree to assume any and all risks of bodily injury, death, or property damage, whether those risks are known or unknown.

I agree that while participating in the Ride I will not obstruct streets or sidewalks, nor will I compromise the ability of the city of Pittsburgh to respond to a public safety emergency.

I forever release all those who organize, run and/or support the Ride, including Danny Chew, any officials, sponsors, employees, volunteers, agents, contractors, and representatives (collectively "Releasees") from any and all actions, claims, or demands that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in the Ride, or (ii) the negligence or other acts, whether directly connected to the Ride or not, and however caused, by any Releasee, or (iii) the conditions of the roads and premises used during the Ride, whether or not I am then participating in the Ride. I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the forgoing release. I further agree to indemnify and hold harmless the Releasees against any and all actions, claims or demands resulting, whether directly or indirectly, from any action or negligence of mine during the Ride.

I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and sign it of my own free will.

If Signed by Parent or Guardian: I verify that the dangers of the activities and the significance of this Release and Waiver were explained to the Participant and that the Participant understood them. I agree to indemnify and hold harmless the Releasees against any and all actions, claims or demands initiated by any parent or guardian of Participant who has not signed this Release and Waiver of Liability Agreement.
